In order to comply with the majority of state and local sales tax law requirements, AUTO BUTLER WARRANTY, INC. must have in its files a properly executed exemption certificate from all of its customers who claim sales tax exemption. If AUTO BUTLER WARRANTY, INC. does not have this certificate, it is obligated to collect the tax for the state in which the property is delivered.
